For the purposes of this request, "communications" includes any and all email and other correspondence, including communications regarding public business occurring on or through private e-mail accounts. This request is for both hard printed and electronic (e.g. MS Word documents, PDF documents, etc.) versions of such documents, and video or audio recordings responsive to the request, stored in any manner whatsoever.


