# Children win by 'unplugging' for safety

### Contest aims to boost children's safety around trains and tracks

Winners of the 2015 edition of Metra's Safety Poster and Essay Contest were honored at the June meeting of the Metra Board of Directors.

Sixteen first-place winners from across the Metra service area were introduced to the Board and presented with plaques and iPads in recognition of their efforts to promote train safety.

The contest is designed to promote and reinforce railroad safety messages and keep our region's children safe around trains. More than 4,800 students from across the region participated in this year's contest, creating artwork or writing essays around the theme "Unplug for Safety, Look Listen Live."

Each year, Metra's Safety Contest invites students in grades K-12 throughout its sixcounty service area to submit poster designs and essays highlighting the importance of railroad safety. Tasked with selecting the winners was a panel of 28 judges, including government officials, representatives from safety and education advocacy groups, business and community leaders, media and railroad professionals.

"Electronic distractions are a

part of all our lives but not being aware of our surroundings can have serious consequences, especially near railroad tracks," said Metra Executive Director/CEO



Don Orseno. "These talented students' posters and essays are creatively helping us reinforce this safety message not just among their peers but to everyone in the region who interacts with the railroad, either as a rider or a motorist."

First-, second-, and thirdplace winners were chosen from each grade level for the Metra Safety Poster Contest. One winner from each grade group – elementary school, middle school and high school – was chosen for the Safety Essay Contest. Firstplace poster and essay contest winners received an iPad, while second- and third-place poster contest winners received \$250 and \$100 gift cards, respectively.

The People's Choice Award winner was Grace Fox, a 10thgrader at Oak Park River Forest H.S. More than 500 people voted online and selected her art-*(Continued on Page 2)*

# **SOUND OFF**

### Pets on trains?

Do you plan to charge dogs that you will start allowing on trains full fare? After all, they will be taking up space like the rest of us. As someone who does not own a dog, I don't want to be subsidizing their ride. No Dog Lover

We have heard from a few riders with concerns about our Pets on Trains proposal, mostly those with allergies. We are very mindful of your concerns – in fact, we shared them before we did some research. That is why we proceeded very cautiously when a petition was presented to us more than a year ago and why we continue to proceed very cautiously with a very limited experiment – weekends only, just the Rock Island line, for three months starting July 4.

Our research found that many other mass transit agencies around the country, including other large commuter railroads, already allow small pets in carriers on their trains. Some of them have been doing it for many years, including the CTA. None that we talked to reported any significant issues relating to their programs – in fact, most saw few if any complaints. Most said that very few people even take advantage of the program so it has no impact on their operations. And none of them saw any cost impacts.

We crafted our rules based on rules used by these other agencies, which work for them. We do not think our ridership differs in any relevant way from the ridership of other agencies that already have successful programs. The rules require these small pets to fit inside carriers and not take up any space that could be used by paying riders. If they are noisy or disturb other riders, they will be asked to leave. Owners will be responsible for the behavior and cleanup of their pets.

We will take it slow, see how the pilot project works, and at the end of the three months we will assess our next step. We want to hear about the experiences of Rock Island riders during the trial. Please go to www.metrarail.com/pets to give us your input.


# **Summer Travel Notes**

### Metra completes work at three stations

Metra last month finished the major work on three significant station projects. First, we reopened the east ends of the Downers Grove Main Street platforms. The \$1.1 million project replaced the existing platforms with new concrete and added diversions to guide pedestrians to designated safe crossings. In addition, the new pedestrian tunnel opened at the Lombard Station. The tunnel is the main component of a \$9.7 million project that also includes rebuilt platforms and new platform canopies. The remaining work is ongoing and is expected to be completed later this summer. And Metra held a ceremony to celebrate the completion of a \$4 million project to rehabilitate the platform and other major components of the Flossmoor Station, including a new warming house, a renovated elevator, a new ramp and stairs and new LED platform lighting.
